Upon arrival at Lima Airport, please proceed to immigration and customs formalities and make your way to the main hall of the airport. Upon exiting the customs checkpoint area, go through the airport taxi counters. You are met by your A&K representative at arrivals hall and transferred to your hotel.

Monday, 9 March 2026 Lima – Cusco - Sacred Valley B- L



Please meet your guide at the reception area of your hotel to visit the "City of the Kings", starting in Plaza Mayor, the original site upon which Lima was founded. You visit the historic Cathedral which is an architectural masterpiece. You then pass the presidential Palace with its excellent photo opportunities and go on to Santo Domingo Convent. After you have finished in the historic center, you are driven across Lima to the Larco Museum where the extensive private collection of pre-Inca ceramics is the largest of its kind in the world. It showcases remarkable chronological galleries providing an excellent overview on 3,000 years of development of Peruvian Pre-Columbian History. For an unforgettable experience, Larco is one of the few museums in the world where visitors can also choose to enter the storage area with its 45,000 classified archaeological objects

Lunch at Café del Museo restaurant. After lunch transfer to Lima airport to board your domestic flight to Cusco.

Upon arrival in Cusco, you are met and transferred directly to the Sacred Valley of the Incas.



Tuesday, 10 March 2025 Sacred Valley – Machu Picchu – Sacred Valley

B-L-D

Admire the massive fortress of Ollantaytambo. This formidable stone structure that climbs massive terraces reaching the top of a high peak, was the valley's main defense against the Antis and was the site of the Incas' greatest victory against the Spanish during the wars of conquest. Constructed of rose-colored granite, this huge installation was once a thriving complex of baths, temples and military barracks. Below the fortress lies a complete Incan town, also called Ollantaytambo, still inhabited and with its original architecture and layout preserved.

Depart: at 10:53 from Ollantaytambo Train Station

Train: Hiram Bingham

Arrive: at 12:24 to Aguas Calientes Train Station.

Note: You can bring only 5kg on board. The rest of your luggage will be transferred to your hotel in Cusco.

A brunch is served on board.

Upon arrival in Aguas Calientes train station, a 25-minute bus ride brings you to the ruins of Machu Picchu.

Accompanied by your guide, explore the city's ruins, and feel its pulse as you visualize the lives of the priests, craftsmen, and servants who inhabited this seemingly uninhabitable citadel. Excavations at the site have revealed skeletons, artifacts and woolen clothing, but no gold. The same precision of assembled stones exists here as in other Incan sites.

In the afternoon, return to Aguas Calientes by shared bus and join the Hiram Bingham train service.


Arrive: at 20:35 to Rio Sagrado Train Station

A light dinner is included on board.

Tambo del Inka a Luxury Collection Resort & Spa Grand Deluxe Terrace – Double



Wednesday, 11 March 2025 The Sacred Valley – Cusco B - L

Please meet your guide at the reception area of your hotel to meet Quechua-speaking farmers and weavers on an inspiring half-day visit to an Andean highland community in the Sacred Valley near the well-known market town and former Inca royal palace of Chinchero. This personal encounter reveals the unique lifestyle and traditions of descendants from the mighty Inca Empire. Explore their village, see and taste the typical food of the area, understand their ancient medical remedies, watch weavers at work, wander into the fields to learn about local agricultural practices and join in a traditional Andean blessing. Drive through the valley to the salt pans of Maras (Salineras de Maras) to appreciate a method of salt extraction used since Inca times. From the village of Maras, continue to Moray, a fascinating archaeological site comprising a series of concentric agricultural terraces, some as deep as 150 meters (492 feet), while enjoying the magnificent views this part of the Sacred Valley offers. This is followed by lunch at Manos restaurant.

Dinner is under your own arrangements.

Thursday, 12 March 2025 Cusco

10:00 Please meet your guide at the reception area of your hotel to discover Cusco by a city tour that includes the Cathedral on the Plaza de Armas, considered to be one of the most beautiful churches in the Americas. Its construction was influenced by the great Spanish cathedrals of the era, reflecting Gothic, Renaissance and Baroque styles. Another ornate church is Santo Domingo, a 16th-century Dominican church and convent built on the foundations of the Koricancha, the Incas' principal religious building. Next you explore the well-preserved ruins of Sacsayhuaman, a testament to Incan architectural skill. Compiled of massive stones, the walls were cut and placed together with incredible precision and without a single drop of mortar to hold them in place. This ancient fortress, where the greatest battle between the Spanish and Incas took place, overlooks the red-tiled roofs of Cusco and the spectacular lush countryside. Finally, you will visit San Pedro market.

ACCOMMODATION:

All accommodation, room type(s) and specification are as shown in the itinerary.

MEALS:

Meals are as shown in the itinerary.

5. TRANSFERS:

Transfers are provided on arrival and departure from airport to hotel and return only where specified in the itinerary.

6. ITINERARY:

Accommodation and arranged sightseeing are subject to change at any time due to unforeseen circumstances or circumstances beyond A&K's control. Every effort will be made to operate tours as planned, but alterations may occur after the final itinerary has been issued. 8. TRANSPORTATION:

Transportation will be as specified in the itinerary.

9. BAGGAGE:

A&K provides handling of baggage only as specified in the quotation. Weight restrictions for baggage on some routes on internal/domestic flights may apply; details of which will be provided with pre-tour documentation. photographs, imagery descriptions used by A&K online and within promotional documentation have been included with the intention of presenting a true and accurate reflection of your holiday destination. However, due to circumstances beyond our control, it is foreseeable that some destinations will change in appearance throughout the year and so may appear to have varied at the time of your stay. eg. due to adverse weather. A&K will of course make every attempt to notify you in advance of your trip as to whether such instances have had any effect on the accommodation or its surroundings if we are made aware of the same, however cannot be held liable in this regard.

15. SURVEILLANCE AND SECURITY

Please note that in some properties surveillance cameras and security equipment may be installed inside and/or outside the property, which may have the capability to remotely monitor or record images and/or sound. If you have any concerns or issues with this, you must inform our team before your trip.

16. ACTIVITES

If A&K is obliged to cancel your holiday in any other circumstances before departure, A&K will use its best endeavours to offer alternative arrangements of equivalent or very closely similar standard and price, if available; travel arrangements of a lower standard and a refund of the difference in price; or will give you a full and prompt refund of all monies paid.

21. FORCE MAJEURE

21.1 Force majeure means unusual and unforeseeable circumstances beyond A&K's control or the control of our suppliers, the consequence of which neither A&K nor its suppliers could avoid even with all due care, including, but not limited to, war, threat of war, riot, civil strife, terrorist activity (actual or threatened), industrial dispute. unavoidable technical problems with transport, machinery or equipment, power failure, changes imposed by rescheduling or cancellation of flights by an airline, natural or nuclear disaster, fire, flood, drought, adverse weather conditions, epidemics or outbreaks of illness and level of water in rivers.

21.2 In the event of a cancellation or material alteration to the trip as a result of the circumstances as described in this clause A&K may in their sole and absolute discretion:

- a. offer the traveller(s) alternative travel arrangements or products of comparable standard as may be appropriate in the circumstances; or
- if alternative travel arrangements or products are not offered by A&K, A&K will make a prompt proportional refund of monies paid by the traveller.

21.3 A&K may charge a reasonable fee to cover the administration costs associated with providing alternative travel arrangements or products.

22. CLAIMS AND REFUNDS:

Refunds are not made for any missed services, except for verifiable extenuating circumstances. Please see our LIMITS ON ABERCROMBIE & KENT'S RESPONSIBILITY clause below. For verifiable claims to be considered, they must be received in writing within 30 days of the termination of the program. Any adjustment considered will be based on the actual price of the services involved and not on a per diem basis. Adjustments will not be made for unused sightseeing trips or meals. A&K will not accept any liability for any claims that are not received within 30 days of the termination of your program. All claims for days missed while travelling should be made in writing within 30 days of the program. Any payment made by A&K, either by way of refund or as the result of a successful claim, will be limited to, and not exceed, the sums retained by A&K in respect of the related booking.

23. LIMITS ON ABERCROMBIE & KENT'S RESPONSIBILITY:

Abercrombie & Kent Peru S.A.C., its employees, shareholders, officers, directors, successors, agents and assigns (collectively A&K), does not own or operate any entity which is to or does provide goods or services for your trip with the exception of a limited number of vehicles. It purchases transportation (by aircraft, coach, train, vessel or otherwise), hotel and other lodging accommodations, restaurant, ground handling and other services from suppliers independent various (including from time to time other affiliated Abercrombie & Kent companies). All such persons and entities are independent contractors. As a result, A&K is not liable for any negligent or wilful act of any such person or entity or of any third person.

In addition and without limitation, A&K is not responsible for any injury, financial or physical loss, death, inconvenience, delay or damage to personal property in connection to the provision of any goods

or services whether resulting from but not limited to acts of God or force majeure, illness, disease, acts of war, civil unrest, insurrection or revolt, animals, strikes or other labour activities, criminal or terrorist activities of any kind, overbooking or downgrading of services, food poisoning, mechanical or other failure of aircraft or other means of transportation or for failure of any transport mechanism to arrive or depart on time.

Further, as consideration for being permitted to participate in the Activities, you release A&K, whether known or unknown, from, and agree not to sue or make claim against A&K for property damage, cancellation of any activities for any reason, illness, negligent rescue operations or procedures, personal injury or death arising from your participation in the Activities, and any activity related thereto, including transportation to and from the site of the Activities, regardless of whether such property damage, illness, personal injury, or death results from the negligence of A&K (but not its reckless, wilful, or fraudulent conduct) and/or from any defect in equipment. You further agree to indemnify and hold A&K harmless with respect to any claim made against A&K by anyone else which a) related to your participation, or b) would be subject to the above release and covenant not to sue if you had made this claim directly yourself.

24. HEALTH PRECAUTIONS:

Please ensure that you consult your personal physician about anti malaria precautions and other inoculations and

vaccinations before travel. Where applicable, please ensure that whilst travelling you carry a valid Yellow Fever certificate.

25. TRAVEL ADVISORIES/WARNINGS:

It is the responsibility of travellers to become informed about the most current travel advisories and warnings by referring to their respective government agencies. In the event of an active State Department or government agency Travel Warning against travel to specific destination location(s) of the trip, should the traveller still choose to travel, notwithstanding any travel advisory or warning, the traveller assumes all risk of personal injury, death or property damage that may arise out of the events like those advised or warned against.

26. TRAVELLERS' REPRESENTATIONS:

If you or any member of your party has any medical problem or disability which may affect your stay, please provide us with full details before we confirm your booking so that we can try to advise you as to the suitability of your chosen arrangements. We may require you to produce a doctor's certificate certifying that you are fit to participate in the tour. Acting reasonably, if we are unable to properly accommodate the needs of the person(s) concerned, we will not confirm your booking or if you did not give us full details at the time of booking, we will cancel it and impose applicable cancellation charges when we become aware of these details.

27. AIR TRANSPORTATION:

30. TRAVEL INSURANCE:

A&K strongly recommend all clients take out comprehensive travel insurance prior to date of travel. This insurance should cover cancellation and curtailment, all medical expenses including evacuation/repatriation,

personal baggage, personal liability, death and permanent disability and travel document insurance.

31. ARBITRATION AGREEMENT:

Any claim arising out of or relating to these Terms and Conditions, to the Limits on A&K's Responsibility clause, to the brochure, to any information relating in any way to the trip, to the trip itself or to any products or services related to the trip, shall be settled in the first instance by binding arbitration in the applicable legal forum as detailed in clause 32 of these Terms and Conditions. In lieu of a personal appearance at arbitration the arbitration may be conducted by telephonic means. Arbitration is the exclusive forum in the first instance for dispute resolution and except as otherwise provided by statute. each party shall bear its own costs and expenses and an equal share of the arbitrator and administrative fees.

32. APPLICABLE LAW AND FORUM:

This agreement shall be construed, interpreted and enforced in accordance with, and shall be governed by the laws of Peru. It is agreed between A&K and the travellers that all lawsuits against A&K arising under, in connection with, or incidental to the tour shall be filed, if at all, in the courts of Peru to the exclusion of the courts of or in any other country or jurisdiction.
